(2) Sponsorship

Any payment or provision of any other financial benefit (other than from the London Borough Havering) made or provided **within the last 12 months** in respect of any expenses incurred by you in carrying out duties as a Member or towards your election expenses.

This includes any payment or benefit from a Trade Union within the meaning of the Trade Union and labour Relations (consideration) Act 1992).

Note

1. Give the name of any person/body which has provided payment or other financial benefit in respect of your duties as a councillor as election expenses.

3. It is insufficient to refer to election expenses returns held elsewhere.

(3) **Contracts**

Any contract which is made between the relevant person (or a body in which the relevant person has a beneficial interest) and the London Borough of Havering:

(4) **Land**

(5) **Licences**

(6) **Corporate Tenancies**

- 1. This applies to any corporate tenancy from the Council to a body of which you or an other relevant person are a partner or director or in which you or an other relevant person hold securities.

(7) **Securities**

Any beneficial interest in securities of a body where

- (a) that body (to your knowledge) has a place of business or land in the London Borough of Havering; and
- (b) either

- (i) the total nominal value of the securities exceeds £25,000 or one hundredth of the total issued share capital of that body; or
- (ii) If the share capital of that body is of more than one class, the total nominal value of the shares of any one class in which the relevant person has a beneficial interest exceeds one hundredth of the total issued share capital of that class.

Note

- 1. The definition below specifies what is meant by 'securities'.
- 2. This applies to where you or an other relevant person have the relevant amount of securities in a body with a place of business or land in Havering

Definitions

The descriptions of the disclosable pecuniary interests, above, are subject to the following definitions:

"relevant person" means you, your spouse or civil partner, or a person with whom you are living as a spouse of civil partner.

"body in which the relevant person has a beneficial interest" means a firm in which the relevant person is a partner or a body corporate of which the relevant person is a director, or in the securities of which the relevant person has a beneficial interest;

"director" includes a member of the committee of management of an industrial and provident society;

"land" excludes an easement, servitude, interest or right in or over land which does not carry with it a right for the relevant person (alone or jointly with another) to occupy the land or to receive income;

"securities" means shares, debentures, debenture stock, loan stock, bonds, units of a collective investment scheme within the meaning of the Financial Services and Markets Act 2000 and other securities of any description, other than money deposited with a building society.
