#### A. DISCLOSABLE PECUNIARY INTERESTS

You have a disclosable pecuniary interest if it falls within the prescribed description of the seven categories set out below and it is your own interest or that of your spouse or civil partner or a person with whom you live as a spouse or civil partner, **of which you are aware**. You must disclose all such Disclosable Pecuniary Interests below. It is a criminal offence to fail to do so.

You are not required to specify whether a person with a disclosable pecuniary interest is your spouse, civil partner or a person with whom you live as a spouse or civil partner as their interest is regarded as your interest.

Note

1. Give the name of any person/body which has provided payment or other financial benefit in respect of your duties as a councillor as election expenses.
2. State the amount or value of any payment/financial benefit/expenses received.
3. It is insufficient to refer to election expenses returns held elsewhere.
4. Payments include expenses paid by a political party.
5. This section applies to payments etc. made within 12 months prior to you completing this form.

(3) **Contracts**

Any contract which is made between the relevant person (or a body in which the relevant person has a beneficial interest) and the London Borough of Havering:

- (a) Under which goods or services are to be provided or works are to be executed; and
- (b) Which has not been fully discharged.

Note

1. This related to any current, on-going contract for good/services/works.

(4) **Land**

Any beneficial interest in land which is within the London Borough of Havering

An address in St Edward's Ward

Note

1. This should include your home or the home of another relevant person that is within Havering where that interest is as freeholder, leaseholder or tenant
2. You should also include any property within Havering from which you or another relevant person receives rent or are mortgagees.

(5) **Licences**

Any licences (alone or jointly with others) to occupy land in Havering for a month or longer

Note

1. This applies to any licences held by you or another relevant person alone or jointly with others

(6) **Corporate Tenancies**

Any tenancy where (to your knowledge)

- (a) The landlord is the London Borough of Havering; and

- (b) The tenant is a body in which you or an other relevant person has a beneficial interest

**Note**

1. This applies to any corporate tenancy from the Council to a body of which you or an other relevant person are a partner or director or in which you or an other relevant person hold securities.

**(7) Securities**

- Any beneficial interest in securities of a body where
- (a) that body (to your knowledge) has a place of business or land in the London Borough of Havering; and
- (b) either
- (i) the total nominal value of the securities exceeds £25,000 or one hundredth of the total issued share capital of that body; or
  - (ii) If the share capital of that body is of more than one class, the total nominal value of the shares of any one class in which the relevant person has a beneficial interest exceeds one hundredth of the total issued share capital of that class.

**Note**

1. The definition below specifies what is meant by 'securities'.

2. This applies to where you or an other relevant person have the relevant amount of securities in a body with a place of business or land in Havering

**Definitions**

The descriptions of the disclosable pecuniary interests, above, are subject to the following definitions:

"relevant person" means you, your spouse or civil partner, or a person with whom you are living as a spouse of civil partner.

"body in which the relevant person has a beneficial interest" means a firm in which the relevant person is a partner or a body corporate of which the relevant person is a director, or in the securities of which the relevant person has a beneficial interest;

"director" includes a member of the committee of management of an industrial and provident society;

"land" excludes an easement, servitude, interest or right in or over land which does not carry with it a right for the relevant person (alone or jointly with another) to occupy the land or to receive income;

"securities" means shares, debentures, debenture stock, loan stock, bonds, units of a collective investment scheme within the meaning of the Financial Services and Markets Act 2000 and other securities of any description, other than money deposited with a building society.

**C. DECLARATION**

A sensitive interest is one where disclosure of the details of the interest could lead to you, or a person connected with you, being subject to violence and intimidation.
